WEBSITE PRIVACY POLICY

Section 1. INTRODUCTION

Section 2. <u>INFORMATION COLLECTED</u>

Business Transfers: If Company is acquired by or merged with another Company, if substantially all of our assets are transferred to another Company, or if we are a part of a bankruptcy proceeding, we may transfer the information that we have collected from you to the other Company.

Legal Proceedings: We may disclose information we collect from you in order to comply with the law, a judicial proceeding, court order, or other legal process, such as in response to a subpoena in compliance with applicable privacy laws.

Section 5. COLLECTING DATA
